In October 2011, the executive director received an increase based on her experience as interim. These deliberations and decisions were documented in the board meeting minutes. In doing so, she was no longer eligible to receive the package's pension of 11% of salary. In lieu of the pension, the equivalent dollar value of the pension was added to her compensation and is routed directly to a 403b plan by the Payroll Administrator.
